All the registered entities under the Hazardous and Other Wastes (Management & Transboundary Movement) Amendment Rules, 2022 are hereby informed that the timelines for filing quarterly and annual returns has been further extended from 1st January 2024 to 31st January, 2025.

All the registered entities on the Waste Tyre EPR Portal (URL: https://www.eprtyrescpcb.in) shall continue to file their quarterly and annual returns till 31st January, 2025 for Financial Year 2023-24. During this period of extension till 31st January, 2025, Extended Producer Responsibility (EPR) Certificate generation & transfer will be carried out on EPR Portal.

The extension of timeline for filing quarterly and annual returns for FY 2023-24 has been approved by MoEF&CC vide letter No.12/136/2021-HSM dated 15th January, 2025 (Copy Enclosed).

Subject: Extension of time line for filing of quarterly and annual returns till 31st January, 2025 under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 (EPR for Waste Tyre) reg.

This has reference to the letter dated 08th January, 2025 received from the Central Pollution Control Board (CPCB) stating that CPCB has received representations from Industry Associations for extension of time period for filing of quarterly and annual returns under the under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 (EPR for Waste Tyre) beyond 31st December, 2024.

2. CPCB further requested Ministry to extend time period for filling quarterly and annual returns till 31st January, 2025 for Financial Year (FY) 2023-24. During this period of extension till 31st January, 2025 Extended Producer Responsibility (EPR) Certificate generation and transfer will also be carried out on the EPR portal.

3. The matter has been examined in the Ministry and in accordance with the subparagraph (6) of paragraph 9 of Schedule IX of the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2024, Ministry hereby extends the time line for filing of quarterly and annual returns by the registered entities for FY 2023-24 till 31st January, 2025. No further extension will be given after 31st January, 2025 and CPCB may take action against non-complying entity as per the rules.
