**Show Cause Notice(SCN) under section 5 of the Environment(Protection) Act, 1986 thereof for Non-Submission of the Annual Return for the Financial Year 2022-23, 2023-24 & FY 2024-25 on Waste Tyre EPR Portal under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 and amendments – reg.**

**WHEREAS**, the Ministry of Environment, Forest and Climate Change (MoEF&CC) has notified the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2022 (hereinafter referred as HoW (M&TM) Amendment Rules,2022), vide notification No. S.O. 5497 (E), dated 31st December, 2022; and

**WHEREAS**, Schedule IX of the HoW (M&TM) Amendment Rules,2022 (Utilization & Management of Waste Tyre defines the Extended Producer Responsibility (hereinafter referred as EPR) as the responsibility of producer of tyre to ensure environmentally sound management of waste tyre in accordance with the provisions of this Schedule;

**WHEREAS**, as mandated under Para 1 (k) of Schedule IX of the HoW (M&TM) Amendment Rules 2022, CPCB has developed the Waste Tyre EPR Portal for implementation of EPR registration, filing returns and performing various other operations for the implementation of HoW (M&TM) amendment Rules, 2022; and

**WHEREAS**, para 3 (1) of Schedule IX of the HoW (M&TM) amendment Rules 2022 mandates the registration of the entities, namely: (a) producer, (b) recycler of waste tyre, (c) retreader; to register on the EPR portal for Waste Tyre; and

**WHEREAS**, Para 7(2) of Schedule IX of HoW (M&TM) amendment, Rules 2022 mandates the Producers registered on the Waste Tyre EPR portal to file quarterly and annual return in the portal on or before the end of the month succeeding the quarter or year; and

**WHEREAS**, as per the Paragraph 7(2) of Schedule IX of the HoW (M&TM) amendment, Rules 2022, the deadline for filing the annual return is the end of the month succeeding the last quarter of the financial year. Accordingly, the last date for filing the annual return for the Financial Year 2022-23 was 30 April, 2023 and last date for filing the annual return for FY 2023-24, the due date was 30 April 2024 and last date for filing the annual return for FY 2024-25, the due date was 30 April 2025; and

**WHEREAS**, as per the How (M & TM) Amendment Rules, 2024, the Central Government may, if it is satisfied that it is necessary so to do in the public interest or for effective implementation of these rules, by order, relax any period within which any return or report is to be filed under these rules by a producer, recycler, retreader and thereof, for a further period not exceeding nine months; and

**WHEREAS**, the portal was made live in April 2023 and the MoEF&CC has approved the extension of the timeline for filing Annual return for the FY 2022-23 and FY 2023-24 beyond 30 April 2024, i.e. till 31 January 2025 and for FY 2024-25 till 15th August,2025 in the public interest and for effective implementation of the aforesaid rules; and

**WHEREAS**, as per para 10 of schedule IX of the above said rules, the Central Pollution Control Board shall laydown guidelines for imposition and collection of environmental compensation on any entity in case of violation of any of the provision of these rules and guidelines issued hereunder and the said guidelines shall be in accordance with these rules of the HoW (M&TM) amendment, Rules 2022; and

**WHEREAS**, as per Para 10 of Schedule-IX CPCB has developed the Environmental Compensation (EC) Guidelines under the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2024 on 03.09.2024 upon the approval of MoEF&CC in compliance with Para 10 of Schedule IX of the HoW(M&TM) amendment Rules, 2022 for levying EC on violations of the provisions under the rules and guidelines and the same is also made available at CPCB website; and

**WHEREAS**, as per the afore-said CPCB guidelines for Environmental Compensation under Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules 2022, Environmental Compensation under EC regime 2 shall be levied against Producers for non-submission of the Annual and Quarterly return. As per the Section 7.0 of the EC guidelines an EC of Rs 25,000/- will be levied for submission of AR within 15 days from last day of return filing, Rs 50,000/- will be levied for submission within 30 days of of last date and Rs 1,00,000/- will be levied on non-submission of Annual Return within 60 days and after which the Annual Return will be auto submitted and EC of Rs 1,00,000/- will be levied; and

**WHEREAS**, as per the record available at Waste Tyre EPR portal, it is observed that your unit has not filed Annual Return for the FY 2022 -23, 2023-24, 2024-25 within the prescribed timeline up to (i.e. 31.01.2025 and 15.08.2025, respectively). Accordingly, the details of EC to be levied on your unit towards non-submission of Annual return for each of the FY i.e. FY 2022 -23, 2023-24 and 2024-25, as applicable, are given at **Annexure1**.

**NOW, THEREFORE**, in exercise of the powers vested under section 5 of the Environment Protection Act, 1986, you are hereby directed to show cause as to why the aforesaid EC amount for non-submission of annual Return shall not be levied on your unit in view of non-submission of annual return for the FY 2022 - 23, 2023-24 and 202425, as applicable and given at **Annexure-1**.

You are hereby required to submit your response to the above directions, within fifteen (15) days of issuance of this notice failing which no further opportunity shall be given to you and appropriate action shall be initiated against your unit under the provisions of the Environmental (Protection) Act, 1986. A soft copy of the response and its compliance details shall be sent to [wastetyre.cpcb@gov.in](mailto:wastetyre.cpcb@gov.in), and a physical copy of the same shall be submitted to Divisional Head, WM-III, CPCB, Delhi – 110032.
